Sanction is hereby accorded to the release of funds to the tune of **Rs 50.00 lakh (Rupees Fifty Lakh,)** only as additionalities for construction of Seven (07) Tribal Hostels in favour of **Director Tribal Affairs, J&K** under the Tribal Sub Plan/Article 275(1)-State Capex Budget 2018-19" for its utilization during the current financial year 2018-19.

**The sanction is subject to the following conditions:**

1. The expenditure shall be made strictly as according to the classification under which funds has been authorized by the Finance Department.
2. Treasury Officer shall not entertain bill without complete classification under which funds has been authorized by the Finance Department.
3. DTA/DDO shall complete all the codal formalities before presentation of bills at the Treasury.
4. Director, Tribal Affairs, J&K shall in his sanction order, indicate the component-wise breakup of the funds to be utilized. A copy of sanction shall also be sent to the Administrative Department for information & record;
5. The DTA shall send the status report about the scheme in terms of Physical/Financial Progress made during the current financial year 2018-19 to the Administrative Department.
6. The funds shall be utilized for execution of the scheme strictly as per originally approved components.
7. The funds are utilized exclusively for the purpose for which these are released without creating any liability for future. No diversion of funds in any case is allowed without prior approval of the Tribal Affairs Department;
8. The other conditions shall remain the same as enumerated in the Government Order No. 554-FD of 2018 dated: 27-12-2018 issued by State Finance Department.


