- That the physical targets commensurate with these funds are achieved in full and there is no shortfall of any kind;

- vi) that there is no overlapping in funding/ covering the area under the scheme from any other scheme of the State / Central Government or any of its organization/Institutions;
- vii) A status report about the schemes with physical and financial progress is furnished to Tribal Affairs Department regularly on Monthly basis for close monitoring.
- viii) The utilization certificate for these funds is furnished to Tribal Affairs Department well before the 31-03-2019 and;
- ix) The expenditure is incurred as per the guidelines and after observing all the codal formalities required under rules.
